CITY CODE ENFORCEMENT IN FULL EFFECT

Are You in Compliance?

The Code Enforcement Division is responsible for inspecting properties to determine if they are compliant with the City's property codes. The Division is responsible for receiving complaints about the condition of the property, determining if the property is in violation of an ordinance, researching ownership and sending letters to property owners who are in violation of the property codes, and testifying in municipal court if necessary. The Division also helps issue permits, electronic filing of plans and documents, and answering questions from the public about property maintenance codes and ordinances.

HIGH GRASS & WEEDS

Not only are high grass and weeds unsightly, but they pose a fire hazard, block visibility for drivers, harbor rodents and snakes and contribute to pests like mosquitoes.

City code requires property owners to keep grass and weeds in their yards and vacant lots under 12 inches.

If your grass is taller than 12 inches, you will receive a notice and will have 7 days to mow property. If you don't, a city contractor will do the job for you and it won't be cheap. You will be billed for the service and **failure to pay for mowing may result in a lien being placed against the property.**

PERMITS - EASY TO APPLY!

Permit applications and permit payments can be submitted by mail at P.O. Box 520, Orange, TX 77631 or in person at 303 N. 8th Street, Orange, TX 77630. For your convenience, permit applications and construction documents can be emailed to our office and permit fee payments may be paid over the phone with a credit card with an additional \$2.50 credit card fee added to the permit fee.

It is unlawful for any person to erect, construct, enlarge, alter, perform major repairs, move, improve, remove, convert, or demolish any building or structure, or install plumbing, electrical or mechanical systems, or perform mold remediation, or perform major landscaping or drainage work, without first obtaining a city building permit. An owner may make minor improvements and repairs on any structure without a permit provided such improvements and repairs are not regulated by this ordinance. An owner planning such improvements and/or repairs shall first contact the City of Orange - **Plans and Inspections Division**.

Staff is available by appointment for assistance with this process or for any questions regarding plans, inspections, and permit operations. Please call (409) 883-1070 to ask questions or schedule an appointment.




